A Tradeswoman Melds Style and Glamour With Ironwork

Bored of her decade-long career as a graphic designer, Blue Coble of Phoenix ditched her desk job and picked up a wrench instead. Now she helps inspire other women to pursue a career in construction.

"I was a manager, and making good money for what graphic designers can make," Coble says. But at the time in her late 20s, she had "hit the ceiling of what I could do where I was. I wanted more."

Inspired by seeing ironworkers assemble the iconic Hoover Dam Bridge spanning Arizona and Nevada, she began to think about performing the physically demanding work herself. After checking out Local Union 75 in Phoenix, Coble decided to give it a go. "I ended up really falling in love with it, and the union was really supportive, so it was easy to stay," she says.

New Funding to Support Women in Apprenticeship, Expand Job Opportunities – WANTO Grant Program

Last week, the Women's Bureau announced the availability of \$1.5 million in grant funding available to recruit, mentor, train and retain more women in quality apprenticeship programs and pursue careers in manufacturing, infrastructure, cybersecurity and health care, among other industries.

"Apprenticeships provide a pathway to family-sustaining jobs," said Women's Bureau Acting Director Erica Clayton Wright. "As the Trump administration works to expand apprenticeship across all industries and sectors of our economy, we remain committed to advancing women's access to these opportunities."

The Women in Apprenticeship and Nontraditional Occupations (WANTO) grant program will award \$1.5 million to community-based organizations to encourage women's employment in apprenticeship and nontraditional occupations. Grants will be awarded to up to six community-based organizations.

Applicants must provide one or more of the following types of technical assistance:

- Developing pre-apprenticeship or nontraditional skills training programs to prepare women for those careers
- Providing ongoing orientations for employers, unions, and workers on creating a successful environment for women to succeed in those careers; and
- Setting up support groups, facilitating networks, and/or providing supportive services for women to improve their retention.

Dove Sifers-Putman, Southeast Market Manager for Environamics, moderated a second panel with women working in the industry, which she calls "male-populated" rather than "male-dominated." And for panelist Rebecca Axford, director of Raleigh-Durham Electrical JATC, events like this demonstrated progress that she

hoped to see for women in the trades.

"I don't think you can have forward progress without changing the scenery," she said of the low number of women in the field. "It was so cool when I got the invite."
